BYLAW NO. 1509

Being a bylaw to amend the Regional District of Central Okanagan Ellison Fire Protection Local Service Establishment Bylaw No. 418, 1990

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 418 being the Regional District of Central Okanagan Ellison Fire Protection Local Service Establishment Bylaw No. 418, 1990, a service to provide fire protection to a portion of Central Okanagan East Electoral Area;

AND WHEREAS the Regional Board deems it necessary to expand the said service area to include the area shown on Schedule 'A' attached hereto;

AND WHEREAS a valid petition in accordance with Section 337 of the Local Government Act to amend the said service area boundary has been received;

AND WHEREAS the Regional Board deems it necessary to reduce the said service area to exclude the area shown on Schedule 'A' attached hereto:

AND WHEREAS the Director of the Central Okanagan East Electoral Area has consented in writing to the adoption of this Bylaw;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. That as a valid petition has been received for the following areas to be included in the fire protection boundary of the Ellison Fire Protection Local Service Area:
