Subject: Growing Communities Fund Allocation

#### Voting Entitlement: All Directors – Weighted Corporate Vote – Simple Majority (LGA s.210)

**Purpose:** To consider the allocation of Growing Communities Fund monies to projects.

#### **Executive Summary:**

On March 16, 2023, the Province of BC announced the creation of the Growing Communities Fund (GCF), a one-time grant program for local governments with the primary goal of increasing the housing supply. The grant has some conditions, one of which is the allocation of the grant to appropriate regional district services by the end of the current calendar year. Actual spending will be reported out on an annual basis as part of the financial reporting requirements under the *Local Government Act* (section 377(1)(a)).

Regional District staff have identified projects that meet the GCF criteria as well as the Regional Board's strategic priorities and provided a recommended allocation of the monies received. They are provided in Appendix A.

The ability to use these funds to support currently planned investments will help to accelerate the delivery of the capital projects and reduce the financial pressures on the residents of the Regional District.

# Recommendation(s):

**THAT** the Regional Board approve the allocation of Growing Community Fund monies as identified in Appendix A – Growing Communities Fund Projects and Allocation Recommendations attached to the report from the Director of Financial Services dated November 16, 2023.

# Background:

In a letter to local government, dated March 16, 2023, the Province of BC announced the creation of the Growing Communities Fund (GCF), a one-time grant program for local governments with the primary goal of increasing the housing supply. The letter outlines the eligible costs and reporting requirements for the grant. Specifically:

"the funding ... should be limited to one-off costs needed to build required infrastructure and amenities rather than funding ongoing operational activities. These funds are to be incremental to currently planned investments and should accelerate the delivery of capital projects".

The allocation of the funds must be determined by December 31, 2023, and the Province requests that the funds be expended within five years of receipt. Year-end reporting on the expenditure of funds will be through a schedule to the annual financial statements.

Ministry staff have confirmed that the intent of the GCF is to enable local governments to build infrastructure for the services necessary to support growth in their communities. The province provided two Frequently Asked Questions (FAQs) documents, one for municipalities and one for regional districts. These are attached and provide answers to questions in the following areas:

- a description of the program,
- eligible uses of the funds,
- allocation of the funds,
- timing of expenditures
- reporting
- reserve funds

Some key take aways from the FAQs are:

- What the funds can be used for. For the RDCO, the following service areas could be looked at:
  - Water & wastewater.
  - Solid waste.
  - Public safety.
  - Active transportation.
  - Public transit infrastructure.
  - Parks.
- What types of expenditures are eligible.
  - Capital costs.
  - Feasibility studies.
  - Design and tendering costs.
  - $\circ$  Land acquisition.
- What cannot be done with the funds.
  - They cannot be contributed to a third party.

- One exception is for infrastructure owned by a First Nation where there is a shared service relationship between the First Nation and the Regional District.
- How the funds should be allocated.
  - The funds are intended to be used for regional priorities.

The funding formula provides per capita funding based on both the regional and electoral area populations. There is also additional funding provided based on the population growth in the electoral areas. The Regional District received a total of \$6.95 million.

These funds represent a significant grant that could support a variety of unfunded investments in the current five-year financial plan. Providing financial support to a regional service will benefit every property owner in the regional district and will meet the intent of the funding. It is also important to recognize the need to support services in the electoral areas in a way that reflects the intent of the funding.

Staff have reviewed the financial plan and identified several projects that would meet the program criteria. Appendix A provides a detailed list of these projects. The total project cost, by service type and department is:
