Good morning everyone, our current President, Sue Huber and former President Karen Bennison asked me to forward this information to you.

The RDCO Electoral Area West and North Westside residents face a 16.5% jump in property with even more in extras and hidden debts.

A budget report released by the Regional District of the Central Okanagan (RDCO) Finance department calls for a base 16.5% increase in property taxes for an average home in Electoral Area West plus additional fees to residents of the North Westside who receive community hall, water or fire services. This comes on the heels of a considerable tax increase in 2023.

Here are the key points from the budget

report and some missing facts:

Property Tax Increase: The report projects a 16.5% increase in property taxes on an average house valued at \$548,313 in Central Okanagan West, translating to an extra \$168, bringing the total to \$1,193 in 2024, up from \$1,025 in 2023.

Extra Fee for North Westside Residents: Those in the North Westside utilizing community hall, water, or fire services will face an additional \$418, marking an \$87 increase from 2023 (\$331). Water rates across all communities are also expected to rise, with the exact amount undisclosed.

Soaring Administrative Overhead: Administrative overhead costs are skyrocketing, with a proposed \$1 million increase in administration departments. The North Westside Volunteer Fire Department is hit with an enormous \$109,447 Administrative Overhead fee, up a staggering 177% from 2020 (\$39,473).

Hidden Deficits and Cuts to Local Services: The budget report fails to reveal a disturbing trend of cutting grant monies which are eligible for local services in Electoral Areas. A meeting on June 8, 2023, saw the rescinding of previously approved local parks capital projects in Electoral Area West, diverting \$4,298,000 gas tax reserves to WFN (IR#9 and IR#10), and imposing a \$435,038 deficit on residents outside of WFN (IR#9 and IR#10) all without public consultation. These measures, which greatly affect Electoral Area finances, were backed by municipal directors and passed despite strong opposition from both Electoral Area Directors.

Questionable Allocation of Growing Communities Grant: Despite an influx of grant funding, especially from the Growing Communities Fund, the budget report lacks clarity in detailing how these funds were allocated. The one-time \$6,950,000 Growing Communities Fund grant from the Provincial Government was distributed to the RDCO based on a per-capita calculation. Notably, Lake Country, Kelowna, West Kelowna, and Peachland each received separate distributions from the Province, distinct from the \$6,950,000 allocated to the RDCO. Despite objections from both Electoral Area Directors Kevin Kraft (East) and Wayne Carson (West) in a November 16, 2023 meeting, the Board approved only \$863,810 (12.4%) for local services within the Electoral Areas, with an overwhelming \$6,086,190 (87.5%) allocated to regional services benefiting neighboring municipalities. This decision, backed by municipal directors, passed despite strong opposition from both Electoral Area Directors. When provided transparency it becomes clear how regional parks received grants for capital improvement, leaving local parks unable to proceed with previously approved improvements, including a multi-use pickleball court at Westshore.

Your voice matters and your input into this budget process is crucial. We urge you to take action:

Having reviewed the details of the financial plan, there are many good points in it. But, as living in the Wilson Landing area and dealing with the after effects of the fire, I was wondering if the provincial government has a grant to help with the temporary drop in our Tax assessment base. I know we lost over \$40 million at LOR, almost \$6 million at Pine Point, plus traders cover, plus Jennu creek plus wilson landing..... For the general RDCO taxes, that loss is mitigated by it is spread across the whole electoral district. (and some of the homes lost in the White rock fire are returning to the tax base.) But where this is going to really hit is in funding our Wilson landing fire department. It is funding totally from the south portion of the west electoral district... which is where the tax base took a big hit. It is proposed an operating increase of about 48% which translates into about 98 % increase. on an actual \$ amount it is significant vs the 16.5 % over all. While I really don't want to see the fire department cut back, is there no money available available from the wildfire recovery grant or any other grant that can be applied? I realize that we are also trying to fund a new \$900K truck in 2027. and there will be a reserve deficit of over \$600k for that purchase. And it will be the service by debt. is there an option to defer some of the reserve costs for this year only. I realize it will increase the deficit.

(FYI my house was ok externally thanks to the wildfire covent required materials and following the Fire smart guidelines for materials close to the house. Even still the fire burned about 30% of our land.)

We live in RDCO West, specifically in Westshore Estates and are disappointed to learn of the proposed property tax increase and apparent changes that will restrict our community's future grant allotments.

We understand costs are increasing overall but a proposed increase of 16.5 % is extreme. It appears even more excessive having just reviewed the 5 Year Financial Plan and not seeing any clear explanation or justification.

Even more disappointing is there is no mention of expanded services, not even a small increase to our local transfer station, upgrades to the community park, or road repairs; all items that would possibly justify a modest increase. At the same time we learn prior funding approvals to upgrade our community park has now been reallocated to regional parks in the larger centres. We have been looking forward to the upgrade to our park and find it frustrating and insulting that this decision was made in-house and not in consultation with affected residents.

On top of this we understand the fees for water and fire services and use of the hall are also going to increase; again with little justification or at least none that was apparent after wading through the briefing notes, draft policies, charts and power point presentations from earlier RDCO meetings.

We also request a clear explanation as to why we have been penalized by prior RDCO decisions that left a deficit in Electoral Area West. These decisions were clearly out of the control of residents yet our area will not be eligible to receive future grant funds until this deficit is paid out.

As well, we were ashamed to read that WFN and OKIB did not receive their portions of prior Community Works funds. It's is admirable that the RDCO recognizes they need to "make WFN and OKIB whole" but it appears this will be corrected at the expense of other communities?

We appreciate this work is challenging and complex. We remain hopeful that the administrators responsible for these decisions consider our feedback and remember the residents you are impacting as we far more than just numbers in your documents.

Dear RDCO.

Along with many of my neighbours living down the North Westside, me and my wife, Sashah are extremely disgusted with your proposed tax changes you plan on forcing upon us this year, and the way you handle money in general. How many more admin pay raises can you give yourselves whilst cutting spending to our residents out here?

We have been Killiney Beach residents for the past 6 years and have seen minimal spending on our community from your fat money coffers. We have been through both significant wild fires over the past couple years, the Terrace Mountain wildfire 10+ years ago, and the flooding disaster 4 years ago. The White Rock wildfire should have been a wake-up call for the RDCO to invest more money and resources into protecting our residents and infrastructure, but this doesn't seem to be the case. Right after the White Rock fire, the Aboriginal Reserve at the North end of Westside Road did a big fire mitigation push for their residents to firesmart the entire area, including installation of more fire hydrants, cutting back flamable ground brush, and more. The RDCO haven't done a thing for us this whole time, nothing has changed, and it's ridiculous. The RDCO was supposed to finish installing the backup generators for our Killiney Beach fire hall/pump station, but we haven't heard anything about that.

Interior Health recommended adding additional filtering to the system due to more advanced contaminants in the water, which the RDCO ignored. Sashah and I, and even our pets, still get upset stomachs when we drink the water out here, and have to boil our water every day in case. Our Killiney Beach community hall is old and run down, it needs more attention, but our maintenance budget has been cut back to nothing because of this tax change. Westshore Estates aren't even getting their promissed pickleball court now thanks to this.

These are just but a few examples of problems stemming from the ridiculous rule of the RDCO as of late and issues being noted by our residents.

I would like the RDCO to give more attention to the North Westside, and rethink your tax plan for us, as you have upset a lot of residents. If this cannot be achieved with your capabilities, then maybe we should hand-off to the RDNO instead, and maybe we will be properly taken care of there.

Hello Tania,

I am writing to express concerns and provide community feedback regarding the proposed 2024-2028 Five Year Financial Plan.

Last year, we met briefly following a draft Budget meeting in February 2023. At that time, I was inquiring as to the lack of Board discussion on the 30% increase in Administrative Expenditures for the 2023/24 fiscal year, which was lacking detail in the Budget Package. You commented at that time, that the increase was due to a 15% overrun of administrative expenditures in 2022/23 (prior to your tenure) that had to be covered and duplicated within the 2023/24 budget. I'd like to confirm that with this current budget, we now have close to a 40% increase in administrative costs over the past 2 to 3 years? Could you roughly provide me an idea what the big expenditure drivers were, so I can explain it to our Community Members?

I recently watched the November 16th meeting, where Staff's recommendations for the allocation of the Growing Communities Fund and Community Works Funds were presented to the Board (Items 7.1 and 8.1). From the surprise response, it was apparent that there had been limited involvement or collaboration with our Electoral Area Directors, prior to presenting these significant funding proposals to the Board. This management style is not reflective of a positive or transparent governance process. It was one of the main issues identified in the Electoral Area West and North Westside services and Governance study, which was presented to the Board 18 months ago. Sadly, it's the ongoing lack of collaboration between our Electoral Director and the RDCO Staff, that leads me to ask the following questions:

- Why are there no longer regular meetings between the CAO, CFO, Chair and Electoral Area Directors to address their individual constituents' concerns or funding needs for the delivery of local government services? Any level of transparent governance would suggest that these types of meetings should be happening monthly or at the very least quarterly.
- 2) Why are there no Board sub-committees that regularly meet to discuss strategy, the allocation of capital funds or proposed administrative budgets? This would allow time to address concerns and have a fully transparent budget process. I recognize that the Board establishes strategic priorities, yet the lack of committee engagement is concerning.
- 3) Was the 2024-2028 Five Year Financial Plan brought before the Electoral Area services Committee to provide input and recommendations on financial matters that affect the Electoral Areas, before presenting this plan to the Board of Directors?

- 4) Can you explain what internal controls are in effect to prevent operating cost overruns during the year? For example, when there is a forecasted 15% overage in budget, what interaction is there with the Board, to receive approval or review options to cut costs during the year?
- 5) Are the RDCO's financial statements subject to an annual audit conducted by the Province or external entities and what are these protocols?
- 6) Why is it, while the allocation and planned use of the original Community Works Funds expenditures for the past 8 years (which was obviously vetted by the Staff and approved by entire Regional Board) is no longer acknowledged as a shared financial responsibility by the Staff and Board?

It is important to note, by proposing and passing the most recent Community Works Funds allocation for 2024 and future years, the Staff and RDCO Board have imposed a financial deficit <u>solely onto our small rural segment</u> of the Electoral Area West. A more reasonable approach would have corrected this by sharing the burden by all Board budgets, based on a population weighting. This leaves our community with a \$480k debt applied to our water system...which is highly questionable. The entire approach taken to dumping this error on our NW communities is definitely not equitable and absolutely must be reconsidered.

- 7) Who within the Administration or Board, drove this WFN retroactive funding agenda? It wasn't necessary....at least not at the dollar level or timing applied.
- 8) Why would the decision to retroactively address the WFN funding be done without public consultation or extensive subcommittee discussions with those it impacted the most? As a non-government 3rd Party, did WFN have the appropriate administrative reporting qualifications or have projects proposed during the past 8 years to receive this funding? Why was it not presented annually and discussed at Council over the past 8 years?
- 9) The Growing Communities Fund (GCF), administered by the Province, distributes funds to both Municipalities and Regional Districts. Why was the funding that Municipalities received from the GCF not taken into consideration when the RDCO Staff was making decisions as to how to allocate funds? While these funds are supposed to be weighted to the advantage of small rural communities, is this not effectively double dipping by the Municipalities if the RDCO Staff does not consider the parallel Municipal funding?
- 10) How are our NW Communities supposed to deal with current issues like a waste transfer station that was designed decades ago with a third of the population, and now has steel bins that are rusted with the bottoms falling out of them? There are no funds to replace them or expand our space? Would those kinds of immediate needs not come before setting aside future funding of an \$8+ million dollar COSAR building project that has not even been discussed in any detail with the Board?
- 11) Have the Municipalities made any financial contributions to the COSAR project or all future costs to be borne by restricted funding to the Electoral Areas?
- 12) Why is the funding for our North Westside recreation court, which was approved in a prior year's budget, now cancelled?
- 13) Per Provincial guidelines, there is supposed to be a <u>heavily weighted allocation</u> of the Growing Community and Community Works funds, to small rural areas. As the Financial Professional for the RDCO, what advice did you provide to the Administrative Team regarding the apparent conflict between Staff recommendations to the Board and the intent laid out in this policy?
- 14) Why did the CAO and the Chair not table the Growing Communities Fund and Community Works Funds resolutions until there was more time for discussion between Council members and staff?

- 15) Why does this recently passed use of Community Works Funds resolution, restricting funds to the rural Electoral Area West, have no defined duration relating to this restriction?
- 16) Do these issues not contravene the Local Government Act, The negligence Act or Federal Funding Agreements? If so, what actions are being considered to correct it?

Tania, it is the consistent disregard for the Electoral Areas and ongoing actions of the RDCO Staff that have created an environment that led the Electoral Area West and North Westside Service and Governance Committee to conclude that the North Westside Communities would be better represented by a Regional District whose policies align with our small community needs. This study concluded:

THAT the Electoral Area West and North Westside Governance and Services Study Committee recommends that the Regional Board of Central Okanagan, in collaboration with the Province and the Regional District of North Okanagan, pursue a further study to explore in detail the services, governance, and financial implications of removing the North Westside Communities from Central Okanagan Electoral Area West and the Regional District of Central Okanagan's boundaries and create a separate electoral area within the Regional District of North Okanagan.

Despite being commissions by the RDCO, it appears that the Committee's recommendations have been disregarded.

It has been 18 months since the study was submitted to the RDCO Board at the regular meeting of September 26, 2022. As a resident of the North Westside and Chair of the Electoral Area West and North Westside Governance and Services Study Committee, the community has received no information of the status of this matter, no press release and no correspondence by the RDCO to date. Although the RDCO subsequently established an Electoral Area Service Committee, the scope and actions of the Committee are a farce. We can only conclude that the Minister of Municipalities and Housing has been erroneously lead to believe that all issues have been resolved. This is far from the truth, as there has been no collaboration. Further, the RDCO has failed to engage with discussions with any members of the Electoral Area West and North Westside Services and Governance Committee.

We officially request that the RDCO Board Chair inform the Minister of Municipalities and Housing that the residents of North Westside Communities continue to advocate for and await the funding to conduct a comprehensive financial analysis. This analysis is crucial for making a well researched decision regarding our future governance and potential boundary move, potentially aligning our neighborhood boundaries with RDNO. This study is not difficult to complete as all the necessary data is available at the two Regional District Offices. We request that the RDCO proactively engage with the Province to advocate for a this comprehensive financial analysis to commence this spring.


An additional note, concerning lack of consultation with our North Westside Communities, relates to an extensive report filed with Council in June of 2023, detailing failures of Fire Services during the 2021 wildfire. To date, there has never been any effort to have Community Hall meetings with the North West Communities (outside of our Electoral Director) to discuss the on-going concerns we have, and how to responsibly move forward, with local input, to rebuild our Community Fire Services. It was our North Westside Communities that built and funded the original Firehalls in this area. We need to be consulted. This is something that needs to be addressed with our community as a whole, <u>in our Community Hall with RDCO HR staff present</u>.

Would you please ensure that this correspondence is included in the 2024-2028 Five Year Financial Plan public input materials that will be presented to the Board.

My name is Joshua Galloway, I reside at Westside Road, and I am writing to provide input regarding the draft 2024-2028 Five Year Financial Plan.

As a resident of Electoral Area West, I am expressing deep concern about the substantial tax increases compared to other jurisdictions within the RDCO. A 16.5% increase on the average \$500,000 home seems unreasonable, especially when compared to tax increases for Kelowna, West Kelowna, Lake Country, Peachland, and Electoral Area East.

I request that the Board to consider the following items:

1) Fire Services Reserves:

a. How are the revenues generated by the North Westside Volunteer Fire Department utilized for equipment and truck replacement?

b. There is a noticeable increase in contributions to capital reserves for new equipment, but it's unclear how McDougall Creek Wildfire revenues are invested into equipment and trucks.

c. Are local taxpayers investing in equipment and trucks that the Regional District is subsequently collecting revenues that get allocated into general coffers?

2) Community Works Fund (formerly gas tax):

a. In 2023, the Board approved a \$435,038 deficit onto residents of Electoral Area West who reside outside of WFN (IR#9 and IR#10). Why isn't this deficit noted and transparent in the 2024 Budget?
b. The Regional Board as a Whole, as governing body, should be accountable for historic spending decisions. Did the RDCO seek public consultation prior to approving the deficit onto the minority population of the electoral area? Does the Local Government Act provide the legislative authority for the Regional District to implement this deficit?

c. Increase the budget to Service 001-Board by \$435,038 and use the funds to offset and remedy the imposed deficit. This increase would ensure that Kelowna, West Kelowna, Lake Country, Peachland, and the Electoral Areas are held equitable accountability for historic spending.

3) North Westside Waste Transfer Station Upgrades:

a. The current footprint of the North Westside Waste Transfer Station is inadequate, leading to traffic congestion, safety concerns, and illegal dumping.

b. Approve provisional funding for waste transfer station improvements and delegate to the Electoral Area Services Committee to receive and endorsement a design before RDCO proceeds with any upgrades.

c. There is an opportunity to build a facility that caters to the needs of our growing community, and I recommend against investing in paving an undersized facility.

4) Admin Overhead:

a. Is Admin Overhead changed on monies that are collected and allocated to reserves? In other words, are Admin Overhead fees charged on money when they go into reserves and again a second time when they are spent on capital investments of service deficits?

b. Provide greater transparency to how Admin Overhead is calculated for each service and identity the Admin Overhead classification and rate that is changed to each service.

c. Admin Overhead changed to the North Westside Volunteer Fire Department has balloon to \$109,447, up 177% from 2020 (\$39,473), is this reasonable?



However, I seek clarity on how the revenues generated from their participation are being utilized. Are these funds allocated appropriately for equipment and truck replacement to enhance the department's effectiveness?
- **3. Grant Funding Allocation:** I am concerned about the criteria used to divert grant funding from local services. Understanding the rationale behind such decisions is pivotal for community members to comprehend the priorities and ensure fairness in resource allocation.
- **4. Deficit in Electoral Area West:** The residents in Electoral Area West outside of WFN (IR#9 and IR#10) are burdened with a substantial \$435,038 deficit. As a concerned member of this community, I request a detailed explanation of how this deficit has accrued and what measures are being taken to rectify the situation. Furthermore, how is the Board as a whole holding itself accountable for historical spending decisions that have led to this deficit?

Looking ahead to the RDCO 2024-2028 Five Year Financial Plan, I am eager to understand the vision and strategies in place. As a stakeholder in our community's well-being, I believe a transparent and inclusive financial plan is crucial for fostering a sense of security and cooperation among residents.

Input, Comments & Questions

• Background & Disclaimer:

I was raised in Manitoba, worked as a CA/CPA in Winnipeg and in Toronto, and retired in Kelowna in late 2009. In my lifetime I have served on committees and have board experience on many organizations including commercial entities (including some national and international), NPOs, charities, Federal & Province of MB government enterprises, and a MB crown corporation. My involvement with municipal government has never been as an elected official or employee, but I specialized for a time as an external auditor of several municipalities (14) and their related entities. I admit that since retiring in Kelowna (14 years ago) I have I not paid much attention to municipal government affairs and thus prior to providing this limited input on the RDCO 2024-2028 Financial Plan I firstly needed to understand the RDCO and so I visited your website starting with the "What We Do" section. The 10 page Guide provided very good background and general information as well.

Thus because of my limited understanding of the purpose and mission of RDCO, my comments and questions that follow focus more on the changes being proposed rather than historical or existing operations & finances. (I tried to differentiate questions and comments)

• Overall Budget Change

 <u>Comment</u>: The "Guide to the RDCO Five Year Financial Plan" provides a lot of very informative detail about RDCO, its purpose, services, funding, etc. It is well prepared and laid out.

At first glance as a Kelowna resident I might not be too alarmed at a 2.2% increase in home taxes except that I must also think about the increases that the Province, SD23, the City of Kelowna and the Strata Corp will need to add to my home taxes and fees (yes, the Strata Corp too is a quasi municipal entity looking after water, sewer, streets, lighting, and so on). Thus it is better for this discussion to look at the 8.5% average increase for RDCO and consider whether all of that is necessary, whether there are economies that can be made in other areas to compensate for new items being added, and whether such increases are sustainable for the rest of the 5 year plan. We may still be living in a growth period in the Okanagan, but one day our grandchildren may be living in an austerity period.

• Capital Expenditures, Reserves, Borrowing, Debt Servicing

- <u>Comment:</u> based on my limited knowledge of historical infrastructure investments at RDCO, my nonexistent understanding on long-term needs, and the complexity of funding such items through a mixture of current taxation, use of reserves, and incurring long-term debt, I am not able to comment in these areas and have few questions on those items at this point.
- Question: I did scan all of the Appendices and noted on Appendix "F" (page 4) a park land acquisition for 2024 in the amount of \$3.5M+ which I presume would be subject to special discussion and decision by the RDCO Board separate from the Budget and Financial Plan approval.
- Similarly, the \$7.6M+expansion of the curbside waste / recycling program for 2024-2025 shown on Appendix "F" (page 3) should be subject to special discussion and decision by the RDCO Board separately from the Budget and not automatically approved with the adoption of the Financial Plan.
- <u>Comments / Question</u>: General comments and a question regarding RDCO vehicles. At page 11 of the document entitled "Regional Board Report – Request for Decision" is a note under "Administration Service / Building Renovations" about an amount of \$395K for installation of EV charging stations (although not from taxation, but funded by reserves).
 - **Question:** has decision been made or is this necessary?
 - Comments:
 - Just like gas station installations are never paid by government or on government land, it seems to me that EV charging stations should not become a RDCO concern or burden on taxpayers;
 - For RDCO-owned vehicles the cost of gasoline, oil and maintenance was presumably always traceable, quantifiable, and used in asset control; likewise for EVs the cost of electricity, charging stations, batteries, and maintenance would need to be monitored per vehicle;
 - Amortization of capital assets is normally done over the useful life of an asset – if this accounting practice was in place for ICE vehicles, it should likewise be implemented for EVs;
 - I don't know if RDCO has many vehicles, however I believe RDCO should adopt a cautious approach to conversion from ICE to EVs as more experience over time is needed to evaluate the long-term capital cost of EVs and replacement batteries. If RDCO has many vehicles it might consider looking at hydrogen ICE vehicles as well as EVs;

 Alternatively RDCO may consider asking the City of Kelowna if they keep such detailed costing and if so consider adopting a similar policy on vehicles (EV, ICE (gas), and ICE (hydrogen) vehicles) as the City does.

Administration Costs

Other than the following comments / questions on staffing, I did not invest time in detailed reviews of the administration costs or overheads.

o **<u>Comments:</u>** Growth of staffing FTE

When looking at **Appendix "C"** I see that you are proposing new positions that would increase **FTE from 151.3 to 157.4 which is a 4%** increase in personnel. I do not know what the FTE increases have been in the past say five years, but I would be interested in knowing what increases in FTE are being proposed for the next few years in the 2024-2028 Financial Plan.

While I am ill-equipped to opine on how much personnel is required, I am always generally concerned with the "*growth of governments everywhere*" and thus I wonder whether we should be looking for areas where personnel can be reduced in order to accommodate new personnel and in an attempt to keep FTE from increasing.

I would certainly want RDCO to consider putting off these new FTE as follows:

- "Parks services" may be seasonal but as far as I am concerned they are quite good as is, and I would consider putting off the expansion of those services;
- The "victim services caseworker" position seems to me as being an example of overlap and duplication in government – I believe this service is the responsibility of the provincial government and that BC does provide victim services already;
- The "accounting advisor" is noted as "term" but I know that "term" often becomes "permanent" and I suggest instead that this transitional IT service be procured from a contractor;
- The "business development coordinator" position is shown as cost neutral, but I question that in the next section below. I have started to scan the RDCO website and plan to study its purpose, goals, mission in more detail, but in the interim I would also ask whether "economic development" is the responsibility of the individual

municipal governments who are members of RDCO and if so, I am concerned that RDCO involvement in that area risks being duplication and unnecessary.

o Question: Staffing vs. Contracting

I find that many organizations tend to oversimplify comparison between inhouse staffing versus contracting out. **Appendix "C"** proposes adding a 1.0 FTE to replace contractors at a savings of \$17,000. **Question:** how is this saving (comparing the cost of contract <u>vs</u> employee cost) being calculated, does it include all costs related to employee compensation: as an example, I attached a sample worksheet to compare staffing costs to contracting out. In-house staffing is sometimes more expensive than contracting out when <u>all</u> costs are considered.

Conclusion

My input is certainly not the result of in-depth review and analysis of the very detailed information you have provided, but just a few points that occurred to me as I perused the documents. As a starting point I always focus my thinking on the sustainability of current programs and services, and then on the long-term impact any new programs and services would have, and finally on whether those programs and services (existing & proposed) are aligned to the organization's purpose and mission.

In conclusion, I want to thank RDCO for inviting comment and questions on the 2024 -2028 Financial Plan.
