**Purpose:** To consider sending a letter to the Ministry of Transportation and Infrastructure requesting

no parking signs along a portion of Old Vernon Road.

### **Executive Summary:**

At the October 21, 2024 Electoral Area Services Committee meeting, the Electoral Area East Director advised that he has received complaints and witnessed excessive and dangerous parking along Old Vernon Road in Central Okanagan Electoral Area East during events at the City of Kelowna's High Noon Park (4720 Old Vernon Road).

The Electoral Area Services Committee is recommending that the Regional Board authorize the Board Chair to send a letter on behalf of the Regional Board to the Ministry of Transportation and Infrastructure requesting that "no parking" signs be installed along Old Vernon Road in the vicinity of High Noon Park for driver and pedestrian safety reasons.
