Investigate unpermitted construction

1. Stop order posted on the house building. Owner(s) onsite with Bylaw, RCMP and building official at time of posting.

2. Owner mailed and emailed a letter titled Notice #1 on July 24/24.

3. Order states: Owner(s) shall cease occupying the 2 unpermitted structures and commence process for permit applications on both.

4. Owners provided requirements for a permit application to be accepted. Evidence of potable water, septic system registration with interior health, drawings, HPO registration and other requirements relayed to the owner.

5. Fines to be issued as per Bylaw #1482 via the RDCO Protective Services Department.

6. All work covered must be uncovered for the purposes of inspection at the owners expense. Failure will result in an Order to demolish the unpermitted buildings. This was relayed verbally to the owner in person at time of site visit on July 9/24.

7. Enforcement to continue with escalation until compliance is achieved.
