Subject: City of West Kelowna - Technical Rescue Services Agreement 2025-2030

Purpose: To release the Technical Rescue Services Agreement with the City of West Kelowna from RDCO closed meeting to an open meeting.

Executive Summary:

At the March 20, 2025, Regional Board closed meeting, the Regional Board passed the following resolution:

“THAT the Regional Board approves the Technical Rescue Services Agreement between the Regional District of Central Okanagan and the City of West Kelowna for the period from April 1, 2025, to March 31, 2030, as outlined in the report from the Director of Protective Services dated March 20, 2025;

AND THAT the Regional Board Chair and Corporate Officer be authorized to execute the Technical Rescue Services Agreement on behalf of the Regional Board of Central Okanagan;

AND FURTHER THAT upon confirmation the preliminary City of West Kelowna labour relations are completed, this item will be brought to an open meeting.”

The City of West Kelowna has advised of the completion of their labour relations. This Agreement is released to the public by way of receiving this Report for information at the May 15th Regional Board meeting.
