- to establish a service within the Regional District of Central Okanagan for the purpose of construction and renovating library building services owned and operated by the Okanagan Regional Library District; and
- borrow up to \$8,000,000 on behalf of the Okanagan Regional Library District for a new library branch in the City of West Kelowna.

Regional District of Central Okanagan, Okanagan Regional Library Service Area Establishment Bylaw No. 1477, 2021 and Regional District of Central Okanagan, Okanagan Regional Library Loan Authorization Bylaw No. 1478, 2021

Pursuant to Section 269 of the *Local Government Act*, the Regional Board of the Regional District of Central Okanagan is proposing to seek the assent of the electors of the Regional District by alternative approval process in accordance with Section 86 of the *Community Charter*. The question before the electors is whether they are opposed to the adoption of Regional District of Central Okanagan, Okanagan Regional Library Service Area Establishment Bylaw No. 1477, 2021 and Regional District of Central Okanagan, Okanagan Regional Library Loan Authorization Bylaw No. 1478, 2021, which if adopted, will authorize the Regional Board to establish a service within the Regional District of Central Okanagan for the purpose of borrowing up to \$8,000,000 on behalf of the Okanagan Regional Library District for a new library branch in the City of West Kelowna.

INSTRUCTIONS

1. If you are opposed to the adoption of Bylaw No. 1477, 2021 and Bylaw No. 1478, 2021, you can sign an elector response form **if you qualify as an elector of the designated service area.**
 2. If you are NOT opposed to the adoption of the bylaws, you need do nothing.
 3. To sign an elector response form you MUST meet the qualifications as either a Resident Elector or a Non-Resident (Property) Elector of the Regional District.
Note: Only one non-resident property elector may sign an elector response form per property, regardless of how many people own the property; and, that owner must have the written consent of a majority of the other property owner(s) to sign the response form on their behalf. Property owned in whole or in part by a corporation does not qualify under the non-resident property elector provisions.
 4. Each Elector Response form may be signed by one elector of the Regional District.

1. All Elector Response Forms must be received by the Regional District on or before **4:00 p.m. on July 12, 2021** to be considered.

No faxed or email elector response forms will be accepted; must be **original signatures.**

2. The number of electors in the service area is estimated to be 164,786. If ten (10%) percent [16,478 electors] of the estimated number of electors in the Regional District sign an elector response form in opposition to the adoption of the said bylaw, Regional District cannot adopt the bylaw without receiving the assent of the electors by referendum.
