## Regional Rescue Program

- Created in March 1989 via an amendment to the RDCO Letters Patent
- Regional Rescue provides the following services:

Auto Extrication

Ice Rescue

Swift Water Rescue

Low Embankment Rescue

Technical High Angle Rope Rescue

Confined Space Rescue

Hazardous Materials Response

Marine Rescue

Radio System

**Emergency Program Management** 

Regional Fire Dispatch

#### • In 2021:

Maximum funding available = \$30.5M

Approved Regional Rescue budget = \$2.5M

Cost to "Average Dwelling" = \$30.32 per dwelling

- COSAR established in 1954 and is operated by volunteers.

#### In 2020, COSAR Funding:

■ EMBC (Tasks) - \$180K

■ Grants/donations - \$110K

■ RDCO - \$27K

#### Emergency Management BC Program

- Search and Rescue is a provincial responsibility funded via programs supported by EMBC, including:
  - expense reimbursement to support deployment;
  - developing support policy;
  - facilitating incident debriefs; and
  - providing input into training standards.
- Throughout the province, various communities have aided local Search and Rescue organizations by making surplus facilities available; providing funding for renovations; or new facilities.

## Framework for Interagency Cooperation


- 2014 Agreement outlining the roles of Regional Rescue Program and COSAR
- The primary goal of the memorandum was to ensure that the:
  - most suitable,
  - best equipped, and
  - trained resources

responded to an emergency as quickly as possible.


Regional Rescue Program = Rapid Response

## GIS – Response Profile

RDCO-GIS Department reviewed COSAR - GIS response data

- 3 Response Scenarios tested:
  - Scenario 1 two locations: Kelowna Central/Ellison Fire Hall
  - Scenario 2 one location: Kelowna Central
    - Scenario 3 three locations: Kelowna Central/Lake Country/Joe Rich
- Majority of COSAR members concentrated in Kelowna area.

## Location Options - Current Site





#### Location Options - New Site

#### Light Industrial property

- 2021 Market Value = \$2,200,000/ac.
- Cost Increasing in +10% per year minimum
- Little or no inventory

#### Other Options

- Lease
- Municipal Holdings



#### Refined Cost Estimate

- Based upon COSAR Needs Report
  - Bay Storage 6000ft<sup>2</sup>
  - Office/Meeting 3950ft<sup>2</sup>
  - Lot Size 1.0 to 1.2 acre
- Estimated Building/Ancillary Cost
  - 2021 Construction Year \$4.760,000
  - 2023 Construction Year \$5,823,000
- Estimated Building/Ancillary/Land Cost
  - 2021 Construction Year \$7,760,000
  - 2023 Construction Year \$8,823,000
- Class "D" Cost Estimates (-10% to +25%)

#### Financial Considerations

- A COSAR building or land purchase does not meet the eligibility requirements for the Gas Tax Fund.
- Borrowing and debt servicing is allowed under the current Letters Patent.
- The project would require approval of the electors:
  - Via: Referendum "Assent of the Electors"; or
  - Via: APP Alternative Approval Process.
- Estimated annual debt servicing costs = 13 20% increase in expenses over 2021 Regional Rescue Budget.
- Increased cost to 'Average Dwelling' = \$4.27 to \$6.52
