### Purpose

 To present the Regional District of Central Okanagan's (RDCO) draft 2022 – 2026 Financial Plan for review and approval.

#### 2022 – 2026 Financial Plan Update – 2<sup>nd</sup> Draft

- Operating revenue and expenditures have decreased \$191K from Draft 1 of the financial plan
- Requisition has decreased \$27K from Draft 1 of the financial plan
- FTE's increased by one in total (2/3 of the year for 1.0 and 0.5 FTE)
- Multiple updates to various cost centres to reflect better information

## Board approved update

- March 03<sup>rd</sup> meeting approval to add a Fund Development Coordinator and a part-time Corporate Services Administration Clerk
- Based on 2/3<sup>rd</sup> of a year for 2022
- Updates in Appendix A, B, F and I
- Used Operating Reserves as a mitigation strategy

- Regional Planning updated for timing related to grant revenue cash flow
- Regional Rescue updated to incorporate debt servicing
