Purpose

- To consider a FrontCounter BC referral for:
 - 1) An Industrial General Land Lease of up to 30 years
 - 2) A Mines Act M-12 Permit Amendment
- Applicant Glencore Canada Corporation



History of Brenda Mine

- Mine operation: 1969-1990
- Detailed closure/reclamation planning: 1988-1993
- Initial closure/reclamation activities: 1990-1997
- Ongoing monitoring and maintenance: 1990-present
- Operation of Water treatment plant

Proposal

 An Industrial General Land Lease of up to 30 years to construct and operate an Organic Waste Recycling Facility

A Mines Act M-12 Permit Amendment to:

- Enable the proposed lease area to be removed from the M-12 permitted mine area for the duration of the Industrial General Lease
- Allow the use of Class A compost material for reclamation of the Brenda Mine site








Proposed Site Plan

- Approx. 13.32 ha area
- To be constructed in three phases:
 - 1. Compost facility
 - 2. Anerobic digester and expansion of compost operation
 - 3. High solids anaerobic digester
- Supporting infrastructure will be required to operate the facility



Project Details

 Proposed system was designed to ensure odour, noise, and liquid discharge emissions will not exceed regulated levels

 Up to 90% of waste input is expected to come from a 100km radius of the site

 Future construction phases plan to include capture of natural biogas for distribution in the local energy system

Applicant Rationale

Provide environmental benefits:

- Divert local organic waste from landfills and converted into products for local use (compost and energy)
- Compost production to progress revegetation of the site

Supports the Clean BC Plan:

- Support waste management by growing opportunities to capture biogas and turn waste into a valuable resource
- Assist with high cost of transporting and recycling waste
- Support a circular economy

Regional Board Strategic Priorities

Environment: We will initiate and support efforts to reduce our environmental footprint, adapt to climate change and connect with nature



Summary

 Referral application is proposing an Organic Waste Recycling Facility referred to as the Brenda Renewables Project

 Proposal meets the Board's Strategic Priorities, Regional Growth Strategy, and Solid Waste Management Plan

 The Province has jurisdiction over Crown Land referrals and is the decision-making authority for the application

Recommendation

THAT the Regional Board support the Glencore Canada Corporation FrontCounter BC referral application No. 574526 for the issuance of an Industrial General Land Lease for up to 30 years and a Mines Act M-12 Permit amendment for the 'Brenda Renewables Project', subject to completion of the following prior to issuance of, or included as conditions of approval:

- An Organic Waste Compost Facility Feasibility Study for the proposed subject property;
- A service-appropriate pilot project for the proposed catchment areas in the Central Okanagan region;
- Public engagement with the community; and
- Any proposed construction, repair, and/or maintenance of the site that falls within the scope of the B.C. Building Code requires a building permit from the Regional District of Central Okanagan.
