A Bylaw to amend Land Use Contract No. 225

Being a Bylaw of the Regional District to authorize the Regional District of Central Okanagan to enter into an Agreement to discharge an existing Land Use Contract.

WHEREAS the Regional District of Central Okanagan pursuant to the *Local Government Act* may discharge a land use contract that is entered into and registered in a land title office subject to the terms and conditions therein set out;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan, in an open meeting enacts as follows:

1. This bylaw shall be cited as Regional District of Central Okanagan Land Use Contract Amendment Bylaw No. 225-04.
2. That Land Use Contract No. 225, 1978 is hereby discharged from Lot 1, DL 3547, ODYD, Plan 30301, Except Plans 32216, KAP61751 & KAP89299, Lot 4 and an undivided 220/268 Share in Lot 1, DL 3547, ODYD, Plan KAP91945, Common Property Strata Plan KAS3867 & Strata Lots 1-24, and an undivided 24/268 share in Lot 1, DL 3547, ODYD, Strata Plan KAS3867, Common Property Strata Plan KAS3858 & Strata Lots 1-24, and an undivided 24/268 share in Lot 1, Plan KAP91945 both in DL 3547 ODYD, Common Property Strata Plan KAS294 & Strata Lots 1-12, DL 3547, ODYD, Strata Plan K294, Common Property Strata Plan KAS287 & Strata Lots 1-18, DL 3547, ODYD, Strata Plan K287, Common Property Strata Plan KAS520 & Strata Lots 1-99, DL 3547, ODYD, Strata Plan K520, Common Property Strata Plan KAS322 & Strata Lots 1-22, DL 3547, ODYD, Strata Plan K322, and Common Property Strata Plan KAS316 & Strata Lots 1-18, DL 3547, ODYD, Strata Plan K316 as shown on Schedule 'A' attached to and forming part of this bylaw.
3. That the Regional District of Central Okanagan Zoning Bylaw map being Schedule 'B' of the bylaw be AMENDED to reflect the change.
4. That Regional District of Central Okanagan Land Use Contract to Discharge Bylaw No. 225-04 comes into force on _____ pursuant to the Local Government Act, Part 14, Section 548.

This bylaw may be cited as Land Use Contract Amendment Bylaw No. 225-04.

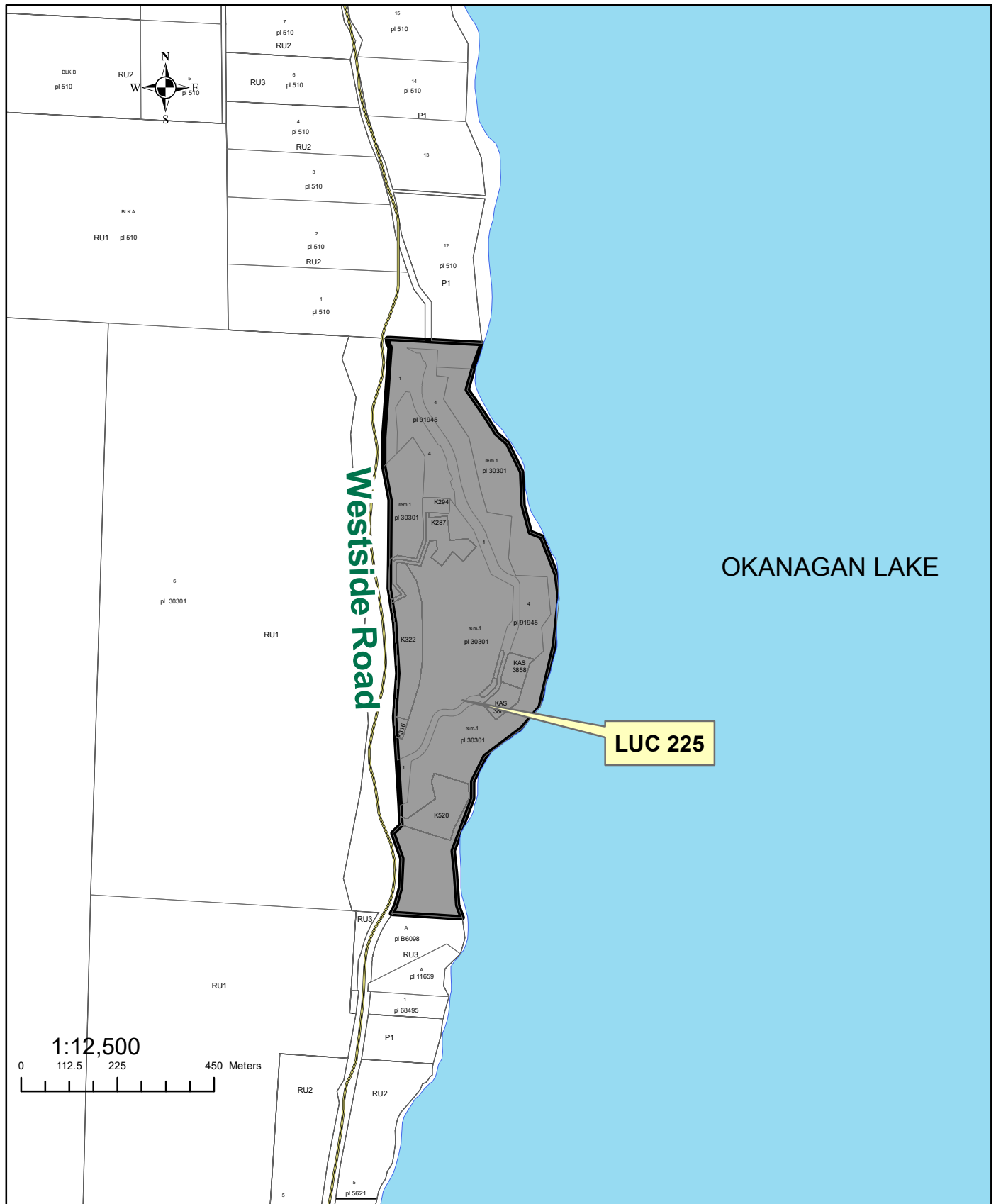
