Subject: Board Meeting Schedule 2022 Update

Voting Entitlement: All Directors – Corporate Vote – Simple Majority (LGA s.208)

Purpose: To consider a change to the RDCO meeting schedule between November 10 and

December 15, 2022.

Executive Summary:

The Westbank First Nation Chief and Council election is September 15, 2022, followed by General Voting Day for the 2022 General Local Election October 15, 2022, with the RDCO inaugural board meeting scheduled for November 10, 2022. Our municipal director and Westbank First Nation appointments to the RDCO board will take place at their respective inaugural Council meetings prior to the RDCO inaugural meeting.

An orientation schedule is being prepared for the incoming Board to include sessions for electoral area directors and the full board. Subjects to be covered include procedural responsibilities, protocols, differences in decision-making at the regional government level, roles and responsibilities of directors and staff, RDCO services, programs, and administration. The orientation program is proposed to span several months and culminate in the 2023-2026 strategic planning sessions in early 2023.

Part of the new board orientation is preparing for the inaugural meeting, and for the annual activities and decisions of the Board – election of Chair, Vice Chair, committee appointments, and the 2023 meeting schedule. As the meeting schedule is an important consideration for all current and new members of the Board, staff are considering options for a schedule that would meet the needs for the business of the RDCO, while also recognizing those of our regional partners.

For the first meetings in November and December 2022, staff are recommending the meeting schedule for the RDCO Board be changed to Thursdays, twice per month. This would remove the Monday conflict with the City of Kelowna Council meetings, avoid other municipal council conflicts, and provide our board with the opportunity of a dedicated day to get oriented to the business of the RDCO.

If the board supports this change, the recommendation provides the required changes to the 2022 regular meeting schedule for November and December 2022.
