Subject: Ellison Heritage Community Centre Fees and Charges Bylaw

**Purpose:** To consider adopting a bylaw to set fees and charges for the use of the Ellison Heritage

Community Centre.

## **Executive Summary:**

Day to day operations and recreational programming services delivery at the Ellison Heritage Community Centre, located in Electoral Area Central Okanagan East of the Regional District of Central Okanagan, were, until spring 2022, provided by the Ellison Parks and Recreation Society (EPRS) through a operating and recreational programming agreement with the RDCO. The EPRS dissolved in mid-2022, and the RDCO Parks Services Department has now undertaken all aspects of community centre operations, including community centre rentals and recreation programming. To support future operations of the community centre, a comprehensive framework that provides rationale for fees and recreational programming benefits as well as an accompanying fees and charges bylaw has been prepared for RDCO Board consideration.

#### **Background:**

In concert with entering into a 20-year series of Operating and Recreational Programming Agreements with the RDCO, the Ellison Parks and Recreation Society (EPRS) previously planned recreation and community activities at Ellison Heritage Community Centre (EHCC). However, when the EPRS dissolved as a society in mid-2022, the RDCO Parks Services Department subsequently undertook day to day responsibilities for all aspects of community centre operations, which includes both facility rentals and community programming initiatives.

RDCO staff are currently receiving a high volume of hall rental inquiries and requests for programs; as such, a framework aligned with the National Recreation Framework has been prepared to support a proposed fees and charges schedule for the community centre that will now be fully operated by the RDCO. This framework provides a basis for the annual calculation of fees and charges for EHCC and establishes user and facility rental categories, a rationale for fees and charges using a benefits continuum model, recovery rates, and a fees and charges schedule.

The Rental Fees and Charges for EHCC have been reviewed by Parks staff and well positioned with comparable fees charged by local public and non-profit community facility providers. The fees collected by EHCC rentals will be used to offset the annual local service area tax requisition associated with the delivery of EHCC services.

 The draft 2023 – 2027 budget for the Ellison Heritage Community Centre has been prepared by Parks Department staff and includes revenue and expenses estimates based on the fees & charges rationale and rates identified in the RDCO User Fees and Charges Framework for Ellison Heritage Community Centre.
