**Subject:** 2022-2026 Financial Plan Amendments

**Voting Entitlement:** All Directors – Weighted Corporate Vote – (LGA s.210)

**Purpose:** To consider amending the RDCO 2022-2026 Financial Plan.

#### **Executive Summary:**

Amendments to the 2022-2026 Financial Plan are required to reflect the impact of increasing capital project costs identified during the procurement process, as well as RDCO staffs' success at obtaining additional grant funding to support operating projects.

Staff are requesting approval to amend the 2022-2026 Financial Plan to include capital budget adjustments and operating budget changes outlined in this Report. Should the Board approve the proposed amendments, a bylaw to amend the 2022-2026 Financial Plan will be brought forward to the December 15, 2022 Board Meeting for consideration.

#### Recommendation(s):

**THAT** the Regional Board approve amending the 2022-2026 Financial Plan to include the following capital budget adjustments:

- In 401 Westside Wastewater Treatment Plant in 2022
  - Add \$260,000 to Capital Expenditures
  - o Add \$260,000 to Transfer from Capital Reserves
- In 046 Dog Control in 2022
  - Add \$41,200 to Capital Expenditures
  - Add \$41,200 to Transfer from Capital Reserves
- In 021 Ellison Volunteer Fire Department in 2022
  - Add \$120,500 to Capital Expenditures
  - Add \$120,500 to Transfer from Capital Reserves
- In 022 Joe Rich Volunteer Fire Department in 2022
  - Add \$10,000 to Capital Expenditures
  - Add \$10,000 to Transfer from Capital Reserves
- In 030 Regional Rescue in 2022
  - Add \$150,375 to Capital Expenditures

- Add \$150,000 to Internal Transfers
- Add \$375 to Transfer from Capital Reserves

- In 110 Regional Planning in 2022
  - Add \$177,500 to Operating Expenditures
  - o Add \$177,500 to Grant Revenue

  - o Add \$142,500 to Grant Revenue
- In 006 Communications & IT in 2022
  - Add \$46,000 to Operating Expenditures
  - Add \$46,000 to Transfer from Operating Reserves
