North Westside Water Systems Generators – Financial Implications

Purpose

 To inform the Board of the Financial Implications to incorporate five (5) back-up generators into the Killiney Beach and Westshore Estates water systems.

Background

- Detailed Service Review of the Fintry, Killiney and Westshore Water Systems began in May 2020
 - How to effectively meet both Canadian Drinking Water Guidelines (CDWG) and Interior Health Regulations (IHR) for potable water.
- Urban Systems presented their final report to the Regional Board on September 26, 2022.
 - The Regional Board adopted the recommendations in the report related to the future interconnection of the Fintry/Killiney and Westshore Water Systems. And
 - Requested that a detailed report on the financial implications of installing generators be prepared for further Board consideration.

Review Parameters and assumptions

- Operational and financing costs for generators have been included in the operations budget for each water system and include:
 - Staff, fuel, repairs and maintenance costs.
 - Financing costs and debenture repayment costs.
- Replacement costs for generators have been included in the Asset Renewal Fees for each water system.
 - All properties will pay increased Asset Renewal Fees, regardless of development status. (vacant land)

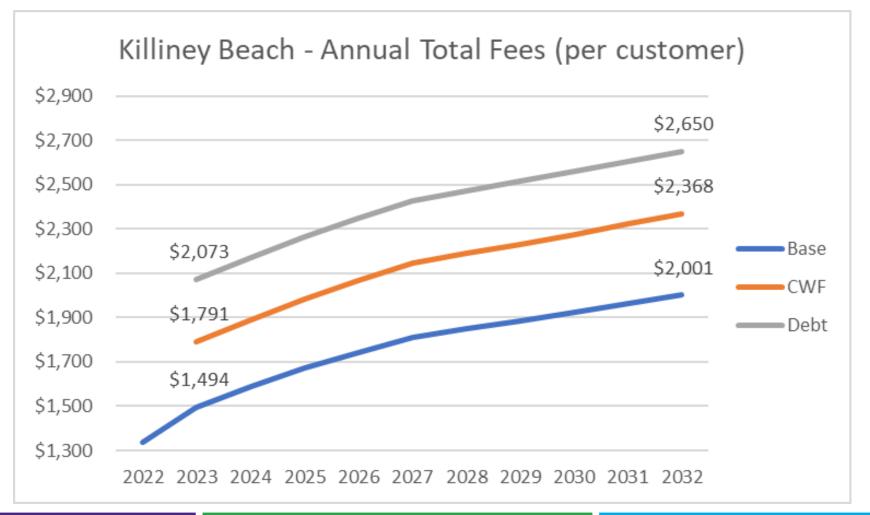

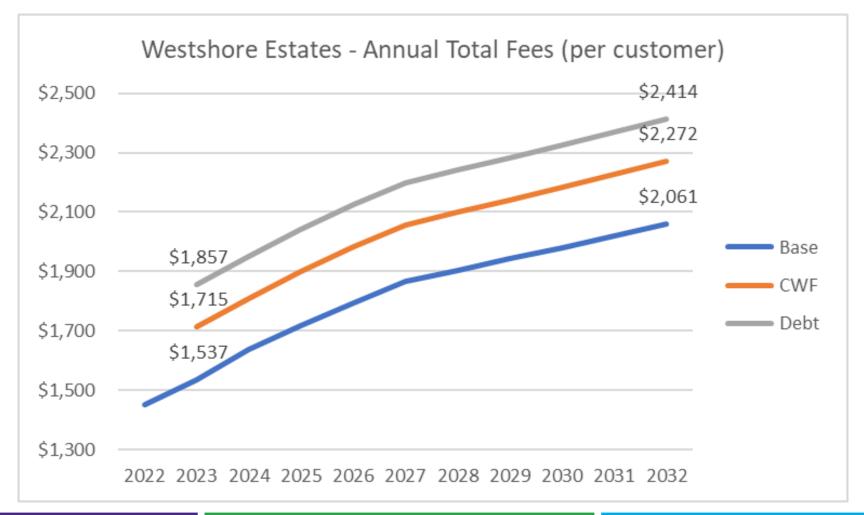
